This form contains standard and mandatory flow down clauses applicable to Government Contracts. This form is found at [www.armorworks.com](http://www.armorworks.com) for all suppliers' reference. The date on the face of the Subcontract, Purchase Order (PO) or Solicitation is the effective date of the clause. Reference to 'award' is inclusive of 'solicitations' when the solicitation is expected to exceed the dollar value shown.

**Example:** The date of 1/1/2022 is on the face of the Purchase Order. The effective date of the flow down FAR 52.202-1 is the most recent date prior to 1/1/2022 or JUN 2020.

The following reference codes are used to identify the dollar threshold requirements for a clause to be in effect.

**Inspection and Government Inspection Rights**
